ABBREVIATIONS FOR LEGAL PERIODICALS

Use this appendix to abbreviate the names of periodicals. The citation form for periodicals is addressed in **Rule 23**. Selected periodicals are listed in alphabetical order by the periodical’s current name. Prior names are listed immediately below the current name. Use the abbreviation that corresponds to the volume you are citing; do not use the current abbreviation if citing older volumes.

To help you determine how to space each abbreviation, the symbol ▲ has been used to designate a space. Do not include this symbol when you type the abbreviation.

The symbol ★ has been used to indicate whether a periodical is nonconsecutively paginated. Under **item 3** in **Rule 23.1(f)**, when the issues of a particular periodical are not consecutively paginated, include the exact date contained on the first page or cover. For consecutively paginated periodicals, include only the year (**item 2** in **Rule 23.1(f)**).

Although this list contains many periodicals, it is not exhaustive. If you cannot locate the name of the periodical you wish to cite in this appendix, to construct the abbreviation, look up each word in the periodical title—as it appears on the title page of the issue you are citing—in **Appendix 3**; you may also abbreviate any word that appears in another title within this appendix. If you cannot find an abbreviation for the word in **Appendix 3** or in this appendix, spell out that word. Note that some words not included in **Appendix 3** are abbreviated in this appendix. Do not “add” abbreviations from this appendix to **Appendix 3** for other purposes. Remember to use **Rule 2** to properly space your abbreviation. Omit the words “a,” “at,” “in,” “of,” and “the” from a periodical title, unless the reader would not be able to discern the publication name. Omit colons, and everything following them, that may appear within the title. Also *omit commas* from the abbreviation. If the periodical title itself contains an abbreviation, use it in the abbreviated name (e.g., BYU J. Pub. L.).

This edition of the *ALWD Citation Manual* includes some alternative abbreviations—or, more accurately, contractions—in **Appendix 3(E)** for certain words. Some of these words, like International (Int’l) and Environmental (Env’tl), commonly appear in periodical titles. You may substitute the contractions in **Appendix 3(E)** for the abbreviations below, but be consistent when doing so.
